### Times Higher Education (THE) Releases World University Rankings 2024

#### Introduction

The **20th edition** of the **World's Best Universities** by the **Times Higher Education (THE)** rankings has been unveiled, showcasing the top higher education institutions globally. Oxford University in the United Kingdom has clinched the coveted first place for an unprecedented eighth consecutive year, with Stanford University in the United States securing second place. The Massachusetts Institute of Technology (MIT) is third in the rankings. The 2024 edition is the largest to date, featuring 1,904 universities from 108 countries and regions, evaluated across 18 performance indicators reflecting their core missions.

#### Top 10 Universities Worldwide

##### British and American Dominance

The list's top 10 universities is a blend of British and American institutions. Leading the pack is the **University of Oxford**, followed by **Stanford University**, and the **Massachusetts Institute of Technology (MIT)**. **Harvard University**, **University of Cambridge (UK)**, **Princeton University**, **California Institute of Technology (Caltech)**, **Imperial College London**, **University of California, Berkeley**, and **Yale University** round out the top 10. This list continues to be predominantly dominated by U.S. universities.

India's ascent in the 2024 rankings extends beyond the number of universities featured. India has now risen to become the fourth most well-represented nation, advancing from sixth place in the previous year's rankings. This upward trajectory reflects the increasing recognition of Indian universities on the global stage.

**Other High-Performing Indian Universities**

Among the Indian universities making notable strides in the rankings are Anna University, Jamia Millia Islamia, Mahatma Gandhi University, and Shoolini University of Biotechnology and Management Sciences. These institutions have secured positions within the 501-600 band, reaffirming their commitment to academic excellence and research contributions.

**India Ranks 40th in Global Innovation Index 2023**

India retains **40th rank out of 132 economies** in the **Global Innovation Index 2023** rankings published by the **World Intellectual Property Organization**. India has been on a rising trajectory, over the past several years in the Global Innovation Index (GII), from a rank of 81 in 2015 to 40 in 2023.

**Collaborative Efforts in Innovation**

The **Confederation of Indian Industry (CII)** has also been collaborating in India’s journey towards an innovation-driven economy. This year, the **NITI Aayog, in partnership with the CII and the World Intellectual Property Organisation (WIPO)**, is hosting, virtually, the India Launch of the GII 2023 on 29th September 2023.

**Which are the most innovative economies in 2023?**

For the 13th year in a row, Switzerland is the most innovative economy in 2023 followed by **Sweden, the United States, the United Kingdom and Singapore**. Discover how other economies are performing in the Global Innovation Index 2023 rankings.

- **Denmark (9th) and the Republic of Korea (10th) remain in the top 10.** France (11th) gets closer, improving one rank this year, while Japan remains strong as the 13th most innovative economy. Israel re-enters the top 15, reaching 14th place.
- After a rapid ascent, gaining 23 positions over the last decade, China ranks 12th this year, dropping one rank relative to 2022.1 China remains the sole middle-income economy to secure a position among the top 30, retaining 3rd place in the SEAO region and top spot in the upper middle-income group (see Figure 11 and Table 3). Belgium (23rd) re-enters the top 25, climbing three ranks.
- All eight Nordic and Baltic economies improved their ranking this year, except for Iceland, which stays at 20th spot. Estonia gains two ranks and edges the top 15, at 16th place. Norway (19th) reenters the top 20. Lithuania (34th) and Latvia (37th) make the largest improvements, gaining five and four ranks respectively, with Latvia re-entering the top 40.
- Apart from China, there are only four other middle-income economies among the top 40 economies, namely, **Malaysia (36th), Bulgaria (38th), Türkiye (39th) and India (40th)**.
- The United Arab Emirates stabilizes at 32nd place, close to the top 30. Saudi Arabia (48th) and Qatar (50th) make it into the top 50. Middle East economies Bahrain (67th), Oman (69th), Jordan (71st) and Egypt (86th) also experience notable improvements in their innovation ranking – Global Innovation Index 2023 51 with Bahrain and Oman entering the top 70, and Jordan just outside. In sum, these are some systematic and positive innovation rank developments in the Middle East.
- Brazil (49th) makes it into the top 50 in 2023, following a gradual ascent over recent years, overtaking Chile (52nd) as the most innovative economy in Latin America and the Caribbean. Uruguay (63rd) and El Salvador (95th) are the only two other economies within the region that improve their ranking in 2023.

- Thailand (43rd) and Viet Nam (46th) consolidate their positions in the top 50, while the Philippines (56th) gets closer. Viet Nam and the Philippines continue marching forward, after a setback in 2022, gaining two and three ranks, respectively. Indonesia (61st) moves rapidly toward the top 60, following a rise over recent years. Together with **China, India, the Islamic Republic of Iran (62nd)**, the Philippines, Türkiye and Viet Nam, Indonesia joins the group of middle-income economies within the GII top 65 that climbed fastest in the GII ranking over the last decade.
- In the last four years, and since the start of the pandemic, Mauritius (57th), Indonesia, Saudi Arabia, Brazil and Pakistan ascended most in the GII, in order of their rank progression.
- In Central and Southern Asia, **Kazakhstan (81st) and Uzbekistan (82nd) are close to the top 80, while Pakistan (88th)** follows closely, the latter overperforming on innovation once again in 2023.
- Nine out of the 26 economies from Sub-Saharan Africa (SSA) covered this year improve their ranking. South Africa (59th) enters the top 60. Rwanda (103rd and low-income group leader) continues moving ahead. Senegal (93rd) and Nigeria (109th) take two of the biggest leaps forward. Excluding island economies, Senegal becomes the region’s third most innovative economy in 2023.

**What India achieved in its G20 presidency?**

**India’s presidency of the G20** has seen significant accomplishments and highlights, as it brought together member countries to address critical global issues, particularly the war in Ukraine, and amplified the voice of emerging markets as mediators. **The New Delhi Declaration**, issued during the two-day G20 Summit, outlined the direction for future negotiations on key economic matters.

**India’s G20 Presidency: Key Achievements and Initiatives**

- New Delhi Declaration:** The G20 Summit’s first day featured the issuance of the New Delhi Declaration, which set the stage for discussions on crucial economic topics. Notably, it introduced a groundbreaking figure of \$5.9 trillion for green financing requirements in developing nations, emphasizing climate financing.

**Switzerland Ranked No. 1 In The World Best Countries Report 2023**

Switzerland has once again claimed the title of the **world’s best country**, according to the latest **U.S. News & World Report’s annual Best Countries rankings**. This marks Switzerland’s second consecutive year at the pinnacle and its **sixth time overall** as the No. 1 nation on the list.

Switzerland excels particularly in entrepreneurship (No. 6), quality of life (No. 6), social purpose (No. 8), and cultural influence (No. 8). It also claims the top spot for being open for business.

**The 2023 Rankings: Switzerland Leads the Way**

The rankings, released recently, reaffirm Switzerland’s supremacy, closely followed by **Canada** at No. 2, **Sweden** at No. 3, **Australia** at No. 4, and the **United States** at No. 5. The United States has slipped one spot compared to its 2022 ranking. In the 2023 rankings, European countries dominate the top tier, securing 16 of the top 25 spots. Notable shifts include **Germany**, which has fallen five spots since 2022, and **Australia** and **New Zealand**, both climbing three places year over year. The Middle East is represented by the **United Arab Emirates**, while Asia boasts Japan, Singapore, China, and South Korea within the top 25.

**India Ascends to 30th Place with an Overall Score of 40.8 in 2023, Up from 31st in 2022**

In 2023, India’s ranking improved by one position, securing the **30th spot** with an **overall score of 40.8**. In the previous year, in 2022, India held the 31st position out of 85.

India achieved its most remarkable performance in the **“Movers” category**, securing the **5th position**. This category evaluates countries based on their potential for future growth and their readiness to face challenges presented by the global economy. In the realm of **cultural influence** and **heritage**, India attained the 29th and 10th positions, respectively. In the **power category**, India claimed the 12th spot.

**The Methodology Behind the Rankings**

The rankings are developed in collaboration with global marketing communications company **WPP** and the **Wharton School of the University of Pennsylvania**. Based on a global survey encompassing **87 countries** and more than 17,000 respondents, these rankings evaluate countries based on **73 attributes** such as dynamism, safety, economic stability, and commitment to social justice. Notably, Cyprus, Honduras, and Zimbabwe have made their debut in the rankings, while **El Salvador** rejoins the list after being absent in 2022.

**RBI (Classification, Valuation and Operation of Investment Portfolio of Commercial Banks) Directions, 2023**

The **Reserve Bank of India** had issued a Discussion Paper (DP) on January 14, 2022 proposing revisions to the current norms for the classification, valuation, and operation of investment portfolios of commercial banks. After considering the feedback received on the DP, the **Reserve Bank of India (Classification, Valuation and Operation of Investment Portfolio of Commercial Banks) Directions, 2023** has been issued.

**Revised norms**

1. The revised Directions include principle-based classification of investment portfolio, tightening of regulations around transfers to/from **held to maturity (HTM) category** and sales out of HTM, inclusion of non-SLR securities in HTM subject to fulfilment of certain conditions and symmetric recognition of gains and losses.
2. These Directions are expected to enhance the quality of banks’ financial reporting, improve disclosures (disclosures of fair value of investments in HTM category, fair value hierarchy, sales out of HTM, etc.), provide a fillip to the corporate bond market, facilitate the use of derivatives for hedging, and strengthen the overall risk management framework of banks.
3. While the revised Directions align the accounting norms for banks’ investment portfolios with global financial reporting standards, important prudential safeguards such as investment fluctuation reserve (IFR), due diligence/limits with respect to non-SLR investments, internal control systems, reviews and reporting etc. have been retained and prudential concerns on reliability of valuation have been addressed.

- The revised Directions shall apply to all commercial banks (excluding Regional Rural Banks) from the financial year commencing on **April 1, 2024**.

**Categorisation of Investments**

The RBI’s new directives require banks to classify their investment portfolios into three main categories:

- Held to Maturity (HTM):** Under this existing category, banks should hold securities with the intention of keeping them until maturity. These securities should provide regular principal and interest payments.
- Available for Sale (AFS):** Securities categorised as AFS are those acquired with the objective of collecting contractual cash flows while also having the option to sell them.
- Fair Value through Profit and Loss (FVTPL):** This is a new category introduced by RBI and includes securities that do not qualify for HTM or AFS. Securities in this category are valued at fair market value, and any gains or losses are directly reflected in the bank’s profit and loss account.

It’s important to note that the HTM category does not include certain securities, such as those with convertible features or loss absorbency features. Preference shares and equity shares are also excluded from HTM classification.

**Initial Recognition**

Under the new RBI guidelines, all investments must be measured at fair value upon initial recognition. The presumption is that the acquisition cost is the fair value unless specific circumstances suggest otherwise. For example, if transactions involve related parties, occur under duress, or take place outside the principal market for that class of securities, the presumption may be tested. Government securities acquired through auctions, switch operations, and open market operations conducted by the RBI will be recognised at the price at which they are allotted.

**Subsequent Measurement**

The treatment of securities varies depending on their categorisation:

- Held to Maturity (HTM):** Securities in the HTM category will be carried at cost and will not be marked to market after initial recognition. Any discounts or premiums on these securities will be amortised over the remaining life of the instrument.
- Available for Sale (AFS):** AFS securities will be fair-valued at least quarterly. Amortisation of discounts or premiums on debt securities in this category will be applied over the remaining life of the instrument.
- Fair Value through Profit and Loss (FVTPL):** Securities in the FVTPL category will be fair-valued, and any gains or losses from this valuation will be directly credited or debited to the profit and loss account.

**Investments in Subsidiaries, Associates, and Joint Ventures**

Investments in subsidiaries, associates, and joint ventures will be held separately from other investment categories. These investments will be initially recognised at their acquisition cost. If the investee entity later becomes a subsidiary, associate, or joint venture, the carrying value will be adjusted accordingly.

**Impairment Evaluation**

Banks are required to regularly assess the impairment of investments in subsidiaries, associates, and joint ventures. Various indicators, such as defaults in debt repayments, credit rating downgrades, and significant declines in fair value, will trigger the need for impairment evaluation. In such cases, banks must obtain an independent valuation and make provisions for impairment accordingly.

This framework aims to categorize NBFCs based on their asset size and other critical factors, providing a clear roadmap for regulation.

#### Understanding Scale Based Regulation (SBR)

Scale Based Regulation (SBR) is a revised regulatory framework introduced by RBI for NBFCs in India. This framework is designed to categorize NBFCs based on their asset size and activities, allowing for more tailored regulatory oversight. Here's a breakdown of the key aspects of the SBR:

#### I. Base Layer (NBFC-BL)

The Base Layer primarily consists of non-deposit-taking NBFCs with assets below Rs 1,000 crore. It includes NBFC Peer to Peer (P2P), NBFC-Account Aggregator (AA), Non-Operative Financial Holding Company (NOFHC), and NBFCs without public funds and customer interface.

#### II. Middle Layer (NBFC-ML)

The Middle Layer encompasses deposit-taking NBFCs and non-deposit-taking NBFCs with assets exceeding Rs 1,000 crore. It also includes NBFCs engaged in specific activities such as Standalone Primary Dealers (SPDs), Infrastructure Debt Fund – NBFCs (IDF-NBFCs), Core Investment Companies (CICs), Housing Finance Companies (HFCs), and Infrastructure Finance Companies (NBFC-IFCs).

#### III. Upper Layer (NBFC-UL)

The Upper Layer includes NBFCs identified by RBI as warranting enhanced regulatory requirements based on specific parameters and scoring methodology. The top 10 eligible NBFCs in terms of asset size will always reside in the Upper Layer, regardless of other factors.

#### IV. Top Layer (NBFC-TL)

NBFCs in the Upper Layer can be moved to the Top Layer if RBI recognizes a substantial increase in potential systemic risk. As of now, the Top Layer remains ideally empty, but it serves as a contingency for increased risk.

#### Placement of Other NBFCs

NBFCs falling outside the predefined layers, such as Investment and Credit Companies (NBFC-ICC), Micro Finance Institutions (NBFC-MFI), NBFC-Factors, and Mortgage Guarantee Companies (NBFC-MGC), may be placed in any of the layers of the regulatory structure depending on various parameters determined by RBI.

It allows for a more nuanced and risk-based approach to regulation, ensuring that NBFCs are subject to appropriate levels of oversight based on their size and activities.
