B. For posts notified in Level-4 & 5, the candidates having eligibility for Level-2 & 3 may also apply. However, only in case none of the applicants for Level-4 & Level -5 are found suitable, then only the applicants of Level-2 & Level-3 may be considered against these posts. However, they will be recruited in Level- 2 and Level-3 only.

- The sports Achievement in the events conducted by Basketball Federation of India after 26-07-2017 shall be considered for recruitment.
- For Boxing: Sports achievements in the events conducted by the Indian Amateur Boxing Federation or any of its affiliates shall not be considered for purpose of recruitment.
- For Power lifting: Sports achievements in the events conducted by the Indian Power lifting Federation (IPF) or any of its affiliated units after 03.10.2017 shall not be considered for purpose of recruitment. However, the certificates issued by the Association of Indian Universities and the International Federations for recognized sports achievements in the game of Power lifting will be permissible.
- The sports achievements in the events conducted by Archery Association of India or its affiliated units shall not be considered for recruitment.

2. ELIGIBILITY CRITERIA:

2.1 Age limit as on 01-07-2021:- 18 to 25 years only.

- (i) Candidates should possess the requisite education and sports achievements on the date of application itself. Qualifications/sports norms achieved after the closing date of notification will not be taken into consideration.
- (ii) Any relaxation in minimum educational qualification as mentioned above is not permissible.
- (iii) Persons if appointed as Clerk-cum-Typists have to acquire Typing proficiency of **30 W.P.M.** in English or **25 W.P.M.** in Hindi within a period of 4 years from the date of appointment. Till such time their appointment to the category will be provisional.
- (iv) The place of posting will be decided by the South East Central Railway administration at the time of offering appointment to the selected candidates.

2.3. SPORTS NORMS FOR RECRUITMENT:-

2.3.1. Categorization of International Championships:-

2.3.2. The minimum sports norms for recruitment of sportspersons against sports quota through Open Advertisement for both the team and the individual events, in different Pay matrix level, or Grade pay/Pay Bands shall be as under:

Note:- (i) All the championships mentioned above should be conducted under the aegis of recognized International/National/ Sports Federations and also recognized by the Railway Sports Promotion Board (RSPB).

- (ii) The recruitment is for the minimum of the scale of pay.
- (iii) For recruitment of sportspersons, on the basis of sports achievements in Junior National championships, the age groups as mentioned below shall only be considered.
- (iv) **The certificates of age, educational qualification & sports norms etc attached with application form will only be considered for recruitment. No certificate will be allowed to be added later on.**

Additional acceptable sports achievements/Minimum Sports norms for certain disciplines:

2.3.3 In Athletics:

For posts of Pay Level 2 only: Medal winning performance in National Inter State Senior Athletics Championships may also be considered.

For posts of Pay Level 4 or 5 : Gold medal winner in Open National Championship (Senior), Inter-State Athletics Championships (Senior) and Asian Championship (Senior) may be considered.

2.3.4 In Golf-

For recruitment against the posts having Grade Pay Rs.1,900 or Rs.2,000 in Pay Band Rs.5,200-20,200: sportsperson having I.G.U. ranking upto 60; subject to single handicap i.e. less than 10 (in order of Merit/Amateur Merit list) shall also be eligible for recruitment. Only the current Annual All India Ranking shall be considered for these purposes.

The highest ranking in the year of recruitment may be considered for the purpose.

The players may be allowed to play in professional tournaments only after completing 5 years after their recruitment after taking NOC from RSPB.

Note: The Sports achievements of current and previous two financial years will only be taken into account for eligibility. Therefore, the Sports achievement of 2018-2019 or later date (on or after 01.04.2018) will only be considered.



4. Mode of Selection:

- (i) Selection is based on total marks obtained by the candidates. The distribution of marks is as under:

- (ii) Trials of the candidates shall be conducted to assess their sports performance and suitability for Railway/Unit team as well as Indian Railways' team. **Trial Committee** shall give its recommendation in terms of either FIT or NOT FIT, for consideration for next stage. The candidates securing minimum 25 marks in trials will be declared FIT and will be considered for next stage of recruitment.

(iii) Selection Procedure:

Selection will be based on performance in sports trials and documents verification to be conducted and finalized by a nominated selection committee. **The venue and date for trials, documents verification etc. will be intimated through website only to the eligible candidates. Candidates are advised to visit given website regularly for getting all updates.** The trials for different Pay Levels may be held separately. Railway administration, South East Central Railway, Bilaspur reserves the right to cancel or modify recruitment process at any time without assigning reasons thereof.

5. Examination Fees:

- (i) **Rs.500** (Rupees five hundred) only for all (except the categories exempted for fee relaxation) with the provision for refunding Rs 400 after deducting bank charges to those eligible candidates who appears in the trial.
- (ii) **Rs. 250** (Rupees two hundreds fifty) for candidates belonging to SC/ST communities, Women, minorities and Economically backward classes with the provision for refunding full amount after deducting bank charges to those eligible candidates who appears in the trial.

6. General Conditions (other than specified above):

- (i) For posts notified in Level-4 & 5, the candidates having eligibility for Level-2 & 3 may also apply. However, only in case none of the applicants for Level-4 & Level -5 are found suitable, then only the applicants of Level-2 & Level-3 may be considered against these posts. However, they will be recruited in Level- 2 and Level-3 only.
- (ii) Candidate may apply for more than one events also for which separate application to be submitted with paying examination fee separately.
- (iii) Selected candidate has to pass prescribed medical examination for allotted post. The medical exam will be conducted by Railway medical authorities prior to her/his appointment.
- (iv) Candidates belonging to SC/ST communities will be given free traveling authority in second class when called for trials.
- (v) No Accommodation and TA/DA will be provided while appearing in the selections/ trials. Candidates should come prepared to stay at the place of trials for 2-3 days. They have to bring their own sports kit/equipment and should make their own arrangement for stay.
- (vi) Immediately after closing date for online application, the candidate may be called for trail at very short notice for which candidate should be ready.
- (vii) **Before trials, the identity of the candidates and original documents of age, educational qualifications, sports norms/achievements will be verified by the screening committee/trial committee. Without producing original documents, candidates will not be allowed to appear in trials.**
- (viii) No post is exclusively reserved for any particular Community.
- (ix) Minorities means Muslims, Sikhs, Christians, Buddhists or Zoroastrians(Parsis).
- (x) Recognized sports achievement should be in the current and/or immediate previous two financial years and sportspersons should be an active player. **Supporting documents should be produced at the time of Trial and documents verification.**
- (xi) Non-fulfillment of any of the criteria mentioned in this notification will make the application liable for rejection for which candidate him/her self will be responsible.
- (xii) Selected candidates are liable to be posted anywhere on South East Central Railway.
- (xiii) The selection shall be decided purely on the basis of merit. In case more than one sportspersons score the same marks, preference will be given to younger candidate to decide the merit.

- (xiv) The sportspersons, who can be fitted in the South East Central Railway Sports Association team, will only be considered.
- (xv) Railway administration reserves the right to alter the stages of recruitment or cancel part or whole of any recruitment process at any stage without assigning any reason.
- (xvi) Sportspersons recruited against sports quota shall be terminated from service if the information and documents furnished by him/her for recruitment are found incorrect/fake at any stage.
- (xvii) Sportspersons recruited against sports quota shall execute a "Service Bond" for a period of 5 years.
- (xviii) Sportspersons recruited against sports quota will undergo probation period of 2 years. The performance of the sports person shall be reviewed before completion of the probation period.
- (xix) Sports persons having sports norms for higher Pay Matrix level (Grade Pay) and who have applied against the vacancies for the lower Pay Matrix can be considered for recruitment against the Pay Matrix level applied for only. In such cases the sports persons has to give an undertaking that he/she will not claim for higher pay level after joining the Railways, on the basis of sports achievements he/she has acquired prior to joining Railways.
- (xx) The decision of Railway Administration in connection with selection will be final. For non-selection of the candidates no correspondence will be entertained. Canvassing in any form will disqualify the candidate. Legal Jurisdiction: For any legal dispute, the jurisdiction will be Hon'ble Central Administrative Tribunal, Jabalpur.
- (xxi) Applicants, who are serving Government or public sector employees should apply with the No Objection Certificate (NOC) of their employer, otherwise application will be rejected.
- (xxii) For any further clarification candidates are advised to go through the website of SECR i.e. www.secr.indianrailways.gov.in. it is also advised that candidate should visit this website regularly for updated information.

2. The certificates being uploaded should be clear. If certificates being uploaded are blur, the application will liable to be rejected.

9. Invalid applications:

The applications having any of the following deficiencies/discrepancies/irregularities will be summarily rejected:

- i) Applications without proper scanned colored photograph and signature. (No black and white photo, No photo with side posture, or sunglass or cap.) Photo should be with white background and with 80% face.
- ii) Application without proper certificate in respect of date of birth, educational qualification, Sports achievements, caste (OBC/SC/ST/OBC declaration) certificate obtained from appropriate authority in prescribed format.
- iii) Candidates should possess the requisite education and sports achievements on the closing date of notification itself.
- iv) More than one application by the same candidate for the same event.
- v) Applications sent manually; (not submitted online).
- vi) Any other deemed irregularity.
- vii) Application without proper fee.
- viii) Application without clear certificates attached

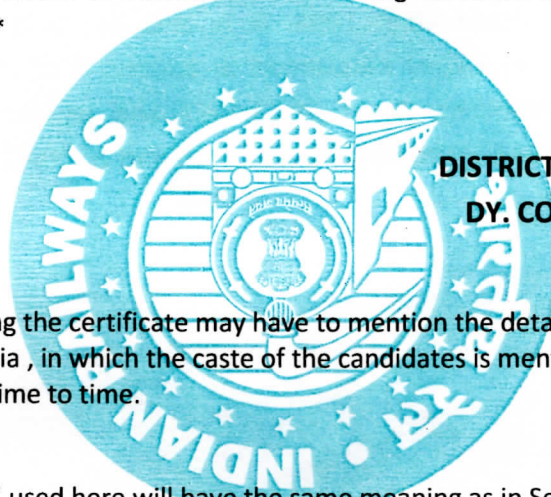

- (4) Union Minister may also recommend to Chairman/RRC for any persons from anywhere in the country.
- (5) Sitting Member of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside.
