- MBBS with PG degree/diploma/DNB in concerned specialty from a recognized university (as well as the specialty recognized/permitted by MCI).
- Candidate should fulfill any one of the following criteria for eligibility:-  
Permanent registered
  - With Delhi Medical Council (DMC) for MBBS and PG/DNB/Diploma with any state of India. **or**
  - With any state Medical Council in India for MBBS and PG/DNB/Diploma in DMC. **or**

- iii. Should be permanent registered with any state Medical Council in India for MBBS, PG/DNB/Diploma and acknowledgement for PG/DNB/Diploma in DMC.
- c) The candidate should complete the tenure of PG Degree/Diploma on or before **22.02.2021.**

3. **Pay Scale:**

Revised Pay Matrix Level 11 (Rs. 67700-208700/-) under CCS (Revised Pay) Rules, 2016 at entry level. Allowances as admissible will be paid.

4. **Age Limit:**

- a) Not exceeding 45 years (relaxable by 5 years for SC/ST, 3 years for OBC) as on **22.02.2021.**
- b) Age Relaxation of 10 years for Persons with Disability (PWD), 15 years for SC/ST and 13 years for OBC candidates of PWD.

- f. **39** posts are reserved for Economically Weaker Sections (EWS).

6. **Terms & Conditions:**

- a.
