### **8. PREPARATION OF SELECTION LIST:**

Final selection of candidates will be made on the basis of combined marks secured by the candidates in the Written Examination, Skill Test and Viva Voce, as per merit, by following the rule of reservation.

However, in case of two or more candidates scoring equal marks, in any category, the candidate senior in age will be placed above in the merit list.

### **9. NATURE OF DUTIES:**

The selected candidates would be required to assist in e-Courts Project related activities; to assist in developing software tools and packages for various court related projects in the areas of PHP, DBMS etc.; Installation and maintenance of Operating System, Office tools, customized application etc.; to install computers and IT peripherals and would be responsible for proper functioning of the same; to maintain and upkeep ICT infrastructure such as hardware, LAN, UPS, VC equipment, KIOSKs, Bio-metric machine etc. with the service providers concerned; to monitor and manage the video-conferencing facility; to maintain proper inventory and records of ICT equipments provided under the e-Courts project to the High Court and subordinate courts and any other work assigned by the superiors.

### **10.PLACE OF POSTING:**
