METHOD OF SELECTION

- a) For candidates who worked in any ESI Institutions of AP on Contract / outsourcing basis with minimum 2 years experience will be directly selected subject to the condition that they fulfill all other conditions.
- b) For remaining candidates Total Marks 100
 - i. <u>Staff Nurses:</u> 75% marks will be allocated against the marks obtained in the qualifying Examination i.e aggregating marks obtained in all the years in the qualifying Examination.
 - ii. <u>Lab Technicians</u>:- 37.5% each will be allocated against the marks obtained in SSC & Qualifying examination.
 - iii. <u>ECG Technicians:-</u> 75% marks will be allocated against the marks obtained in Intermediate Examination.
 - iv. Weightage up to the maximum of 15% marks will be to the staff working in Government of AP and other Government of India schemes on contract /outsourcing basis.

Particulars of weightage for marks as shown in (iv)

- ➤ 1 mark for each six months of service
- No marks will be given for the service rendered less than six months
- > The candidates who were terminated from contract/outsourcing service on any disciplinary grounds/adverse remarks will not be considered.
- v. Upto 10% marks @ 1 mark for each completed year after passing of requisite qualification to the said post.

CONDITIONS & INSTRUCTIONS

From 01-07-2020 on wards all the outsourcing appointments will be made through APCOS only. This department will process the applications received from the eligible candidates and short listed merit list will be submitted to APCOS for issue of placement intimation letters. The candidates who received placement intimation letters should work at any ESI Hospital / ESI Diagnostic center / ESI Dispensary in the respective Zone / District of AP or in any other place according to the need of the Department. The appointments are purely temporary and on outsourcing basis as mentioned. The candidates should reside at their bonafied Head Quarters. Disciplinary control is in accordance with provisions of APCS(CCA) Rules, 1991.

Candidates make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility in all respects. Any candidate furnishing false / incorrect information or making false declaration regarding his / her eligibility at any stage or suppressing any information is liable to be debarred from the selection conducted by the Department and summarily rejection of their candidature for this selection and future selections.

This Department is vested with conducting selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by any one causing or likely to cause breach of this duty in such manner or by such action as to violate or likely to violate the fair practice followed and ensured by the Department will be sufficient cause for rendering such questionable means as ground of debarment.

The decision of the Department / selection committee pertaining to the application and its acceptance or rejection, as the case may be, and conduct of the counseling and at all consequent stages culminating in the selection or otherwise of any candidate shall be final and all respects and binding on all concerned under the powers vested in it. This department / committee also reserves its right to modify the terms and conditions laid down in the notification for conducting the various stages up to selection duly intimating details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process.

Candidates are informed that the recruitment process will be done transparently according to merit, weightage and rule of reservation etc. Hence, they are advised not to resort for any unethical practices and cooperate with the selection Committee for transparent selection of candidates.

AGE LIMIT

- a. OC candidate should not have completed 42 years as on 01-04-2021 (should not have been born before 01-04-1979.
- b. SC/ST/BC candidates should not have completed 47 years as on 01-04-2021 (should not have been born before 01-04-1974.
- c. PHC candidates should not have completed 42 years as on 01-04-2021 (should not have been born before 01-04-1969.
- d. Ex-service men shall be allowed to deduct from his age a period of three years in addition to the length of service rendered by him in the armed forces for purposes of the maximum age limit;

APPLICATION PROCESS FEE

Each applicant must pay application process fee of Rs. 300/- (Rupees three hundred only) and for SC/ST/BC/PHC/Ex-Service men Rs. 100/- by way of Crossed demand draft drawn on any nationalized bank in favor of "The Director, Insurance Medical Services, Vijayawada" payable at Vijayawada.

RULE OF RESERVATION TO LOCAL CANDIDATES

Reservation to local candidates is applicable as provided in the rules and as amended from time to time as in force as on the date of notification. The candidates claiming reservation as local candidate should enclose the required study certificates from 4th class to 10th class issued by the concerned school authorities. In case of candidates who studied privately should submit residence certificate issued by concerned Tahsildar for a period of 07 years preceding 10th class. **Subsequent production of the certificates will not be entertained.**

Residence certificate will not be accepted in respect of the candidates studied in any educational institution up to SSC or equivalent examination. Such candidates have to produce study certificate invariably.
