3. IMPORTANT INSTRUCTIONS/INFORMATION

a) For application on Deputation basis:

- i) Maximum upper age limit for appointment shall not exceed 56 years as on the closing date of receipt of applications
- ii) No provision for reservation exists for the posts to be filled up on deputation basis.
- iii) All applicants must fulfil the eligibility conditions for the post and the other conditions stipulated in the advertisement as on the last date of receipt of the applications. They are advised to satisfy themselves before applying that they possess at least the essential qualifications and/or experience laid down for the post as on the last date of receipt of the applications. Applicants are advised to send their application only through proper channel as applications sent directly or as advance copies shall not be entertained.

- vi) The concerned University/Institution/Department/Competent Authority, while forwarding the application shall certify that the applicant, if selected, will be relieved to take up the appointment within one month of the receipt of the offer of appointment.
- vii) The pay of the selected candidate will be regulated under the provisions contained in the DoP&T O.M. No. 6/8/2009-Estt.(Pay II) dated 17.06.2020 as amended from time to time.

b) For application through Direct Recruitment on Contract basis:

- i. Maximum upper age limit for appointment on contract is 50 years as on closing date of receipt of applications. Maximum upper age-limit for NIFT employees may be relaxed upto five years or total length of service rendered (on regular and/or long-term contract basis) whichever is less.
- ii Age relaxation to SC/ST/OBC/PWD candidates would be as per applicable Gol Rules.
- iii. The initial appointment on direct recruitment shall be on long term contract basis, initially for a period three years, which would be extendable for another three years on the basis

of performance. Such long-term contract employees would be considered for regular appointment after satisfactory completion of five years of service.

c) GENERAL INSTRUCTIONS FOR DEPUTATION AND DIRECT/CONTRACT BASIS:

- i) The applicant must be a citizen of India.
- ii) The prescribed qualifications are the minimum and the mere possession and fulfilling the essential and desirable qualification does not entitle the applicants to be called for the interview.
- iii) All applicants must fulfil the essential requirements of the post and other conditions stipulated in the advertisement as on the last date of receipt of the applications. They are advised to satisfy themselves before applying that they possess at least the essential qualifications and experience laid down for the post as on the last date of receipt of applications. No enquiries with reference to eligibility will be entertained.
- iv) The application should be accompanied by self-attested copies of the relevant educational qualification, experience and caste/category certificate (wherever applicable).
