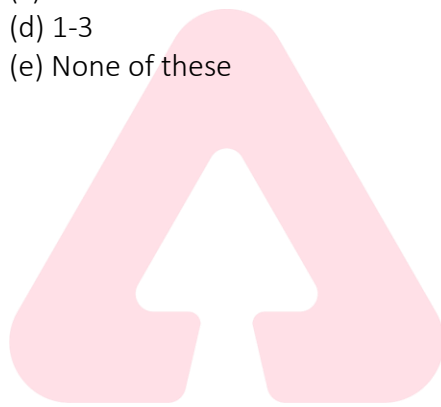

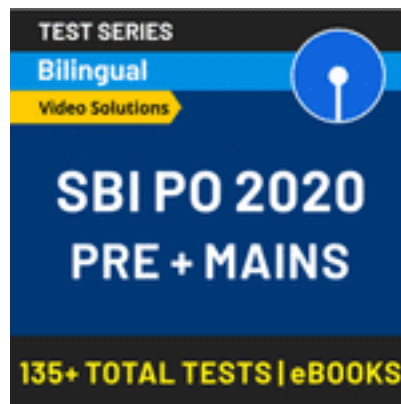

Solutions

S1. Ans. (a)

Sol. Here, 2-3 i.e., 'proven-employing' is the correct combination of words which will replace each other to make the sentence grammatically and contextually correct. The sentence thus formed is,

'Economics is probably one notable exception, where models and techniques *employing* higher mathematics have *proven* to be highly fruitful.'

S2. Ans. (b)

Sol. Here, 1-4 i.e., 'move-space' is the correct combination of words which will replace each other to make the sentence grammatically and contextually correct. The sentence thus formed is,

Matter and energy tell space how to curve and that curved space lays out the path upon which matter and energy move.

S3. Ans. (b)

Sol. Here, 1-4 i.e., 'hopeful-century' is the correct combination of words which will replace each other to make the sentence grammatically and contextually correct. The sentence thus formed is,

'By the end of the 19th *century*, keeping the mountains politically quiet and socially peaceful was both a desirable aim and a *hopeful* description.'

S4. Ans. (d)

Sol. Here, 1-3 i.e., 'bottom-economies' is the correct combination of words which will replace each other to make the sentence grammatically and contextually correct. The sentence thus formed is,

Because economies are reopening or partially opening in the U.S., the likely bottom of the Pandemic Recession will be this quarter.

S5. Ans. (c)

Sol. Here, 2-4 i.e., 'unprecedented-economy' is the correct combination of words which will replace each other to make the sentence grammatically and contextually correct. The sentence thus formed is,

'In India, the massive expansion of the national *economy* allows for commodification of mountain in ways that are *unprecedented*.'

S6. Ans. (a)

Sol. Here, 2-3 i.e., 'immigration-reductions' is the correct combination of words which will replace each other to make the sentence grammatically and contextually correct. The sentence thus formed is,

Policy changes that result in reductions of international trade or immigration could also be catalysts for stagflation.

S7. Ans. (d)

Sol. Here, 1-3 i.e., 'pledges-concentrations' is the correct combination of words which will replace each other to make the sentence grammatically and contextually correct. The sentence thus formed is,

'Concentrations of carbon dioxide continue to rise, and current country *pledges* would not stem this increase even by 2030.'

S8. Ans. (c)

Sol. Here, 2-4 i.e., 'indistinguishable-scales' is the correct combination of words which will replace each other to make the sentence grammatically and contextually correct. The sentence thus formed is,

When we look out at the Universe, particularly on large cosmic scales, it behaves as though space were virtually indistinguishable from flat.

S9. Ans. (a)

Sol. Here, 2-3 i.e., 'mathematical-theories' is the correct combination of words which will replace each other to make the sentence grammatically and contextually correct. The sentence thus formed is,

'Not all areas of sciences are able to construct *theories* or models that have the level of *mathematical* rigor that theories of physics enjoy.'

S10. Ans. (b)

Sol. Here, 2-3 i.e., 'address' will be replaced by 'ability' to make the sentence grammatically and contextually correct. The sentence thus formed is,
"The tools of **macro** policy can **address** the business cycle, but their **ability** to address the **overall** problem is limited".

S11. Ans. (c)

Sol. The correct answer choice is option (c). 3-1 i.e., 'positions-criticized' is the combination of words that will replace each other in order to make the sentence grammatically and contextually correct.

S12. Ans. (e)

Sol. Here, the sentence is absolutely correct. No any interchange is required.

The sentence remains the same as "**Policymakers** in India were in a **terrible** bind in 2001 owing to **fiscal** stress and in 2010 owing to **inflation**".

S13. Ans. (c)

Sol. Here, 2-4 i.e., 'decline' will be replaced by 'investment' to make the sentence grammatically and contextually correct. The sentence thus formed is,
"A root-cause **analysis** of the **decline** in trend growth from 2011 **onwards** will take us to the decline in private **investment**".

S14. Ans. (a)

Sol. Here, 1-4 i.e., 'harnessing' will be replaced by 'discretionary' to make the sentence grammatically and contextually correct. The sentence thus formed is,
"The useful path lies in **harnessing** the situation to push for the **required** long-term **structural** reforms in tax policy and tax administration, instead of thinking in terms of **discretionary** fiscal policy".

S15. Ans. (d)

Sol. Here, 1-3 i.e., 'sharply' will be replaced by 'spreading' to make the sentence grammatically and contextually correct. The sentence thus formed is,
"Indian markets fell **sharply** today, tracking global peers lower, as fears about the economic **impact** of China's **spreading** virus outbreak curbed risk **appetite**".
