Only three designations are there between the youngest person and B. B is elder to E and younger to D. The age difference between C and E is the same as the age difference between E and H. Age of E is a multiple of 5. The one who is SO has an age which is a perfect cube. The age of G is a prime number. D is just senior to F whose age which is an even number. H is junior to B but is not 27 years old. The number of designations between H and G is the same as the number of designations between G and A.
