Solutions

S1. Ans. (d)

Sol. Here, Error lies in part (A). "Intelligent" will be replaced by "Intelligence". Also, the correct sequence of the statement (I) is CABD. The sentence after rearrangement is, Biden announced he is putting the foreign (C)/governments "on notice," promising to direct the intelligent (A)/ community to probe foreign election interference (B)/and put ample resources into quashing such efforts (D)

Hence, **option** (d) is the right answer choice.

S2. Ans. (c)

Sol. Here, Error lies in part (B). "For" will be replaced by "With". Also, the correct sequence of the statement (II) is DBCA. The sentence after rearrangement is,

Stock investors are feeling comfortable with the idea that the current economic weakness is supported by stimulus measures.

Hence, **option (c)** is the right answer choice.

S3. Ans. (a)

Sol. Here, Error lies in part (C). "Smaller" will be replaced by "Small" as with smaller, there should be some comparison in the later part of the sentence. Also, the correct sequence of the statement (III) is ACBD. The sentence after rearrangement is,

A global network will be costly to build out, but small coworking firms can serve local companies by providing more flexibility.

Hence, **option (a)** is the right answer choice.

S4. Ans. (b)

Sol. Here, Error lies in part (B). "entity" will be replaced by "Entities" as "15" is mentioned before that. Also, the correct sequence of the statement (IV) is CDAB. The sentence after rearrangement is,

The Supreme Court on Monday agreed to consider a staggered schedule for the payment of telecom dues by 15 entities.

Hence, **option** (b) is the right answer choice.

S5. Ans. (e)

Sol. the statement (V) is grammatically and contextually correct. The correct sequence of the statement (V) is **BDCA**. The sentence after rearrangement is,

Fath<mark>er Aym</mark>anathi<mark>l had be</mark>en arranging ration and meal for the children and their families from the first day of the lockdown.

Hence, **option** (e) is the right answer choice.

S6. Ans. (a)

Sol. Here, error lies in part (C) of the sentence (I). "To" should be used instead of "Too". Hence, option (a) is the right answer choice.

S7. Ans. (b)

Sol. There is a contextual error in part (D). Here, "and" should be used instead of "Because" to make the sentence contextually correct. Hence, option (b) is the right answer choice.

S8. Ans. (d)

Sol. Here, error lies in part (B) of statement (III). "Its" should be used instead of "It's". Hence, option (d) is the right answer choice.

S9. Ans. (c)

Sol. The statement (IV) is both grammatically and contextually correct. Hence, **option (c)** is the right answer choice.

S10. Ans. (b)

Sol. Here, error lies in part (D) of the statement (V). "effectives" will be replaced by "effective". Hence, option (b) is the right answer choice.

S11. Ans. (b)

Sol. A-F can be joined to make a grammatically and contextually correct sentence.

The bench heard arguments from several senior lawyers appearing for various telecom firms.

Hence, **option (b)** is the right answer choice.

S12. Ans. (a)

Sol. A-F and C-D can be joined to make a grammatically and contextually correct sentence.

A-F: There is a need to ensure that the IBC (Insolvency and Bankruptcy Code) is not being misused by companies.

C-D: Rohatgi assured that the company would pay the dues if the payments schedule was staggered.

Hence, **option (a)** is the right answer choice.

S13. Ans. (c)

Sol. B-E can be joined to make a grammatically and contextually correct sentence.

B-E: Britain announced on Monday it would suspend its extradition treaty with Hong Kong.

Hence, **option (c)** is the right answer choice.

S14. Ans. (d)

Sol. A-E and B-D can be joined to make a grammatically and contextually correct sentence.

A-E: District surveillance officer A.K. Lal said the situation in the district was alarming as health workers were now getting infected.

B-D: Officials in Hong Kong and Beijing have said the law is vital to plug gaps in national security.

Hence, **option (d)** is the right answer choice.

S15. Ans. (b)

Sol. A-F can be joined to make a grammatically and contextually correct sentence.

A-F: The communities which have high representation compared to their share in the OBC population will be put in one category.

Hence, **option (b)** is the right answer choice.
