- 2. The candidature of all the candidates short listed for verification is purely provisional subject to fulfilment of eligibility criteria with regard to age, essential qualification and reservation etc.
- 3. The candidates must ensure that they belong the respective category/sub category as mentioned in the above list.
- 4. Candidates belonging to other categories/sub-categories are required to submit the requisite certificates in the prescribed proforma given in the Annexure-A to Annexure-G of the detailed advertisement
- 5. Candidates seeking age relaxation as Government Employee/ESIC Employee shall have to produce Service Certificate.
- 6. In the detailed advertisement for the post of UDC, MTS & Steno. it has been notified that the facility of scribe shall be given only to persons with benchmark disabilities in the category of **blindness**, **locomotor disability (both arm affected-BA) and cerebral palsy**, if so desired by the person. For other category of persons with benchmark disabilities, the provision of scribe can be allowed on production of a certificate to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on his behalf, from the Chief Medical Officer/Civil Surgeon/Medical Superintendent of a Government health care institution as per prescribed proforma appended at Annexure G of the advertisement.

As such, PWD candidates other than in the category of **blindness**, **locomotor disability** (**both arm affected-BA**) **and cerebral palsy**, who have availed services of scribe in the Phase I and/or Phase II Exam for the post of MTS are required to submit certificate regarding physical limitation to write in the prescribed proforma appended at Annexure – G of the advertisement.
