Sol. Ludovit Odor took office as Slovakia's new caretaker Prime Minister, pledging to bring calm and professionalism to his country. Slovak President Zuzana Caputova appointed Odor to the post earlier on Monday after the resignation on May 7 of former caretaker Prime Minister Eduard Heger.

S2. Ans.(c)

Sol. Avian Influenza (also known as bird flu) is a highly contagious viral disease that primarily affects birds, but some strains can also infect humans.
