Sol. K Rajaraman has been appointed as the new chairman of the IFSCA. The IFSCA was formed in April 2020 through the enactment of the International Financial Services Centres Authority Act, 2019. The headquarters of IFSCA is situated in GIFT City, Gandhinagar.

S3. Ans.(b)

Sol. India received a total FDI inflow of US\$70.97 billion in FY 2023, which includes equity inflows, reinvested earnings, and other capital sources. This marked a decrease from the US\$84.83 billion recorded in FY 2022.

Sol. The FCRA is administered and enforced by the Ministry of Home Affairs, Government of India.
