Solutions

S1. Ans.(a)

Sol. GST exemption on satellite launch services supplied by ISRO, Antrix Corporation Limited, and New Space India Limited (NSIL) may be extended to such services supplied by organizations in the private sector to encourage startups.

S2. Ans.(c)

Sol. Majorana zero modes are formed by combining two Majorana particles and differ from conventional particles in that they do not have separate antiparticles. Experimental progress has been made in their creation, as mentioned in the previous information.

Sol. Retail inflation in India surged to 4.81% in June due to higher food prices.
