#### **Solutions**

#### S1. Ans.(b)

Sol. Ujjal Bhuyan served in the Gauhati High Court, and S. Venkatanarayana Bhatti served in the Andhra Pradesh High Court before being appointed to the Supreme Court.

# S2. Ans.(b)

Sol. The Jan Vishwas Bill aims to decriminalize minor offences and replace them with monetary penalties, with the goal of promoting ease of doing business and reducing the burden on the courts.

## S3. Ans.(e)

Sol. The RBI cancelled the registration of Nanma Chits and Financiers Ltd, Chidrupi Financial Services Ltd, Goldline Financial Services Ltd, and Kailash Auto Finance Ltd.

# S5. Ans.(b)

Sol. Global public debt reached a record \$92 trillion in 2022, with developing nations accounting for 30% of the total. Private creditors hold 62% of the debt in developing countries.

## S6. Ans.(c)

Sol. The DAC approved the procurement of 26 Rafale Marine aircraft and the

acquisition of three additional Scorpene submarines.

### S7. Ans.(b)

Sol. The Rafale Marine aircraft will be procured from the French Government based on an Inter-Governmental Agreement (IGA).

### **S8**. Ans.(d)

Sol. The visit is expected to finalize several agreements to enhance defence cooperation, including the acquisition of 26 naval variants of the Rafale combat jet and three Scorpene-class submarines. Additionally, discussions on joint development of fighter jet engines with Safran, a French aircraft equipment manufacturer, and a roadmap for defence-industrial cooperation are anticipated.

Sol. The Acts mentioned in the question are part of the 42 Acts to be amended under the Jan Vishwas Bill, but the Legal Metrology Act, 2019, is not listed.

# S10. Ans.(a)

Sol. The inclusion of 43 new implementing partners under the SAMARTH scheme was announced by the Ministry of Textiles.

### S11. Ans.(e)

Sol. Implementing partners under the SAMARTH scheme will receive a 5% increment in financial support provided by the Ministry of Textiles.

### S12. Ans.(a)

Sol. The Grand Cross of the Legion of Honour was conferred on Prime Minister Narendra Modi by French President Emmanuel Macron.

# S13. Ans.(c)

Sol. The spacecraft launched aboard India's heaviest rocket, Launch vehicle Mark-III a.k.a LVM3 on a journey to the Moon. The spacecraft will complete the 3,84,000 kilometers-long journey in nearly 45 days to attempt a soft-landing on the Moon by end of August. The Chandrayaan-3 mission began its journey to the Moon onboard India's heaviest rocket, the Launch Vehicle Mark-III. The spacecraft is neatly packed in the launch fairing of the rocket as it begins its journey to the lunar world.

Sol. This year marks the 25th anniversary of the India-France strategic partnership, and PM Modi's visit will provide an opportunity to chart the course of the partnership for the future.
