Sol. India's foreign exchange reserves hit \$622.47 billion, a one-month peak, as of February 2, per RBI data released on February 9. The reserves surged by \$5.74 billion in the latest week, driven by RBI intervention and fluctuations in foreign asset values.

S2. Ans.(c)

Sol. The current hydrogen demand in Uttar Pradesh is estimated at 900,000 tonnes per annum, particularly in sectors such as fertilizers and refineries. This highlights the existing market size and potential for growth.

Sol. With the joint victory in the SAFF Women's U-19 Championships, India secured their fourth age-group title in women's SAFF competitions. This victory marked their first win on Bangladeshi soil in such competitions.

Sol. The event showcased over 320 stalls dedicated to exhibiting the unique handicrafts, handlooms, and agro products of the eight culturally rich states of Northeast India.
