Solutions

S1. Ans.(b)

Sol. India aims to increase its non-fossil fuel-based electricity generation to 50% by 2030, up from the current 42%, as part of its commitment to cleaner energy sources.

S2. Ans.(d)

Sol. The government aims to invite approximately \$26 billion in private investment into its nuclear energy sector to enhance electricity production from non-carbon-

emitting sources.

S3. Ans.(d)

Sol. According to the Bureau of Energy Efficiency (BEE) statistics, Karnataka leads in public EV charging stations with a total of 5,059 stations.

Sol. 50 navies are participating in the Milan naval exercise hosted by India. This demonstrates the significant international involvement in the exercise, highlighting its importance in fostering maritime cooperation among numerous countries.
