# Solutions

# S1. Ans.(b)

Sol. Anurag Jain, Secretary of MoRTH, stated that the targeted range for highway construction in India for FY24 is between 12,000 to 13,000 kilometers.

# S2. Ans.(d)

Sol. The Philippines recently ratified the ILO Convention 190, making it the first Asian country to do so. This significant step highlights the country's commitment to addressing workplace violence and harassment comprehensively. Japan, China, South Korea, and Indonesia have yet to ratify this convention.

#### S3. Ans.(b)

Sol. During a two-day visit to India, Greek Prime Minister Kyriakos Mitsotakis and Indian Prime Minister Narendra Modi engaged in extensive discussions aimed at bolstering bilateral cooperation across various sectors. The visit marks the first by a head of state of Greece to India in 15 years.

### S4. Ans.(c)

Sol. As of the latest update, 38 countries globally have ratified the ILO Convention 190. This indicates a growing international consensus on the importance of addressing workplace violence and harassment.

### S5. Ans.(e)

Sol. Mswipe Technologies is headquartered in Mumbai. Mumbai is a prominent financial and commercial hub in India, making it an ideal location for the headquarters of a fintech company like Mswipe.

### S6. Ans.(b)

Sol. The Ministry of Ports, Shipping & Waterways partners with IIM Shillong for India's first Gati Shakti Research Chair, focusing on multimodal logistics. Goals include academic research, collaboration with global experts, and supporting the PM Gati Shakti Masterplan for regional logistical capacity.

### S7. Ans.(b)

Sol. NTPC Renewable Energy Ltd. (NTPC-REL) launched its first solar project in Chhattargarh, Rajasthan, adding 70 MW to the NTPC Group's capacity. With 17 projects underway, totaling over 6,000 MW, NTPC-REL aims to strengthen India's renewable energy sector. The project will benefit 60,000 households and mitigate 3 lakh tons of CO2 emissions annually.

### S8. Ans.(d)

Sol. The government appointed A S Rajeev, former MD and CEO of Bank of Maharashtra, as Vigilance Commissioner in the Central Vigilance Commission (CVC). Rajeev retired voluntarily, with the Department of Financial Services accepting his request. Bank of Maharashtra confirmed the appointment through a regulatory filing.

### S9. Ans.(d)

Sol. The amended FDI policy permits 100% FDI under the automatic route for

manufacturing components and systems/sub-systems for satellites, ground segment, and user segment. This initiative aims to boost domestic manufacturing, promote technology transfer, and support the 'Make In India' initiative.

#### S10. Ans.(e)

Sol. Nokia's 6G Lab, where the collaboration with IISc is taking place, is located in Bengaluru. This strategic location enables close collaboration with leading academic institutions and access to a vibrant technological ecosystem, facilitating innovative research and development in 6G technologies.

### S11. Ans.(a)

Sol. Bank of Baroda forecasts India's GDP growth to be around 6.75-6.8% in FY25, as per their report. This projection indicates sustained economic momentum, aligning with other estimates by reputable financial institutions.

### S12. Ans.(d)

Sol. The IMF upgrades its estimate for India's GDP growth by 40 basis points to 6.7% for the current fiscal year, indicating improved economic outlook compared to its previous forecast.

### S13. Ans.(c)

Sol. PayPal registered with FIU-IND, as mandated under the Prevention of Money Laundering Act (PMLA), 2002. FIU-IND is responsible for collecting financial intelligence related to offenses under PMLA, reinforcing transparency in financial transactions and combating money laundering activities.

### S14. Ans.(a)

Sol. Morgan Stanley Research forecasts India's GDP growth to moderate to 6.5% in FY25. This projection reflects a decline from the 6.9% growth projected for FY24.

### S15. Ans.(a)

Sol. SJVN Limited, a Mini Ratna, Category-I and Schedule 'A' Central public sector enterprise under the administrative control of Ministry of Power, Government of India, has marked a significant milestone in its journey towards sustainable energy solutions. On February 23, 2024, SJVN announced the commencement of successful commercial operations of its 50 MW Gujrai Solar Power Station in Kanpur Dehat, Uttar Pradesh.
