A. The reservation for the EWS candidates will be guided by the above Gazette Notification read with Memo No.325-PAR(AR)/3P-1/2019 dated 09.07.2019, issued by the Personal and Administrative Reforms Department, Govt. of West Bengal.

B. In this respect, the General category candidates, who have already submitted their online application in the portal, and who belong to E.W.S. category will be required to edit their application form regarding the status of EWS. If any candidate does not modify the application form, it will be assumed that he/she does not belong to EWS category.

**C.** As no vacancy for Unreserved candidate is left for the post of English Stenographer and Night Guard after inculcation of EWS category, the application of General candidates (not belonging to **EWS** category) who have already applied shall be cancelled and their application fees shall be returned by 25.07.2024.

Date of application is extended till 25.06.2024 for all categories.

The candidates who had applied earlier (except for EWS category) need not apply afresh.

## GENERAL INSTRUCTIONS FOR APPLICANTS BEFORE ONLINE SUBMISSION OF APPLICATION.

- All items in the Application Form are to be filled in by the applicant online. No
  offline application will be accepted. No other form of application will be accepted.
  Other than online mode, no other mode of application will be entertained.
  A candidate is NOT allowed to apply for more than 1(one) post.
- SC/ST/OBC-A/OBC-B/EWS candidates belonging to States other than West Bengal will be treated as UR Candidates only.
- Application Fee is to be paid through online recruitment portal in the payment section via payment gateway. The details of application fee are already mentioned above. Payment gateway Charges will be additionally levied upon application fee as per rates specified by the payment gateway.
- Scanned passport size recent color photograph of the applicant (Image format will ONLY be.jpg and of maximum size 100 KB is to be uploaded in the specified section in the online portal. Further unclear/hazy/doctored/morphed images if uploaded by the applicant and detected at any later stages of this recruitment process will result in summarily rejection of the applicant. The applicant has to retain 6 identical copies of this photograph which has been uploaded and will have to produce them before the Authority as and when called for.
- Scanned full signature of the candidates is to be uploaded in the space specified and the
  image should be in .jpg format and will be of maximum size 100 KB and preferred
  dimension is 200X 100 pixels. Scanned signature exceeding the maximum size will not
  be accepted by the online recruitment portal.
- Applications are to be made through online mode only in the prescribed format provided in the website:-

### One Candidate can apply for one post only.

Candidates are advised to strictly follow the instructions given in the above website and in this notification for making online application and payment of application fees. Failure to do so shall result in cancellation of the application and forfeiture of the application fees.

• Candidates may please note that unless the Application Fees is received by the Bank, the application will be treated as INCOMPLETE. Usually Bank provides the status of successful receipt of the payment within 72 hours of the transaction i.e. if fees is paid on 23<sup>rd</sup> August, Bank will update its status to us within 26<sup>th</sup> August. For Ex-Serviceman Category [for EXSM category]: Requisite Certificate issued by Competent Authority as mentioned in this notification issued on or before the last date of application.

For Proof of Economically Weaker Section (for EWS Category): Requisite Certificate issued by Competent Authority as per Notification No.325-PAR(AR)/3P-1/2019, dated 09.07.2019 as mentioned in this notification issued on or before the last date of application.

**No Objection Certificate (NOC)** [for existing employee of government/public sector undertaking]: Requisite No Objection Certificate (NOC) in favour of the candidate from his/her employer issued on or before the last date of application.

**Proof of Computer Training:** Certificate(s) in Computer Training from recognized Institution(s).

The General Candidates who have already submitted their online application in the portal, and who belong to E.W.S category can edit their application for uploading certificate of E.W.S through the option button for editing application.

After the online application is complete, the applicant is to download a filled-in form containing all information as submitted by the applicant and preserve the same for future reference.

Applicants are advised to enter correct/valid data in respect of various information as sought for. Incorrect details will be summarily rejected at any stage of the recruitment process.
