NOTIFICATION FOR RECRUITMENT OF MERITORIOUS SPORTS PERSONS IN THE DEPARTMENT OF POSTS IN THE CADRE OF POSTAL ASSISTANTS/SORTING ASSISTANT, POSTMAN & MULTI TASKING STAFF.

Last date for receipt of applications: 06.12.2021

Application are invited from meritorious Sportspersons for appointment as Postal Assistant/Sorting Assistant, Postman and Multi Tasking Staff against the vacancies of Direct Quota reserved for Sports Quota Recruitment as shown in Annexure A, B & C in Rajasthan Postal Circle, Jaipur.

The detailed guidelines, eligibility criteria, vacancy position, other conditions and instructions for the Direct Recruitment are given below, which must be read carefully by the applicant and satisfy him/herself about the eligibility to the post and then apply for the same. It will be presumed that all guidelines, conditions and instructions are acceptable to the candidates who are applying for the post.

2. Selection Criteria:-

Meritorious Sports Candidates will be selected for appointment based on the instructions contained in the Department of Personnel & Training OM No. 14015/1/76-Estt (D) dated 04.08.1980 and as amended from time to time and consolidated instructions issued by DOP&T vide OM no- 14034/01/2013-Estt.(D) dated 03.10.2013.

- First Preference: Candidate who have represented the country in an INTERNATIONAL competition with the clearance of the Department of Youth Affairs and Sports.
- Second Preference: Candidate who has represented a State/Union Territory in the Senior or Junior Level National Championship organized by the National Sports Federations recognized by the Department of Youth Affairs and Sports or National Games organized by the Indian Olympic Association and have won medals or position up to third place. Between the candidates participating in Senior and Junior National Championship/games the candidates having participated and won the medal in Senior National Championship gets preference.
- Third Preference: Candidates who have represented a University in an Inter-University Competition conducted by Association of Indian Universities/Inter-University Sports Board and have won medals or position up to third place in finals.

- Fourth Preference: Candidates who have represented the State School in the National Sports/Games for School conducted by the All India School Games Federation and have won medals or position up to third place.
- Fifth Preference: Candidates who have been awarded National Award in Physical efficiency under National Physical Efficiency Drive.
- Sixth Preference: Candidates who have représented a State/Union Territory/University/State School Teams at the Level (II) to (IV) above but could not win a medal or position in the same order of preference.
- NOTE 1: Only in the event of tie, where the number of candidates have similar level of certificates /achievements, following criteria has to be followed-
 - (a) Those who have secured a higher position or won more than one medal will be given the preference.
 - (b) In case of tie after applying (a) above date of birth of the candidate(older in age) will be given preference.
 - (c) In case of even tie in the date of birth of the candidate, the name of the candidate in the alphabetical order criteria has to be followed.
- NOTE 2: Participation in Individual and team event/item will be given the same preference.
- NOTE 3: No preference will be given for winning more than one medal/position except in case of tie as mentioned in Para(a) of NOTE 1.
- NOTE 4: In case of any doubt the status of a tournament, the matter will be decided by the Department of Personnel & Training in consultation with Department of Sports and Youth Affairs.
- NOTE 5: The decision of competent authority i.e. Chief Postmaster General, Rajasthan Postal Circle, Jaipur will be binding on all.

5. Age Limit: As on 06.12.2021 (last date receipt of application)

(a) Postal Assistant/Sorting Assistant/Postman: Between 18 to 27 Years
[Relaxable by 3 year for OBC, 5 years for SC/ST and for Government Servant of different category in accordance with the instruction issued by the Centre Government time to time]

(b) Multi Tasking Staff: Between 18 to 25 Years

[Relaxable by 3 year for OBC, 5 years for SC/ST and for Government Servant of different category in accordance with the instruction issued by the Centre Government time to time]

Note: In addition, a special relaxation of upper age limit up to a maximum of 05 years for all categories will be admissible. This concession will be admissible only to those sports persons who satisfy all other eligibility conditions related to educational qualifications etc. and furnish a certificate in the prescribed form issued by an authority as mentioned in Para- 4.



6. Educational Qualification & other qualifications:

(A) Postal Assistant/Sorting Assistant:-

- (i) 10+2 Standard or 12th Class pass from a recognized University/Board.
- (ii) The candidates will be required to furnish Certificate of Basic Computer Training from a recognized Computer training institute before issuance of appointment letter. Computer Training Certificates from Central Government/State Government/University/Boards etc., will also be acceptable for the purpose. This requirement of Basic Computer knowledge Certificate is relaxable in case where a candidate has studied Computer as a subject in matriculation or Class XII or Higher educational qualification and in such case a separate Certificate will not be insisted upon.

(B) Postman :-

- 12th Standard pass from a recognized Board.
- (ii) Knowledge of local language (i.e. Hindi). The candidate should have studied local language (i.e. Hindi) at least up to 10th standard.
- (iii) The candidates will be required to furnish Certificate of Basic Computer Training from a recognized Computer training institute before issuance of appointment letter. Computer Training Certificates from Central Government/State Government/University/Boards etc., will also be acceptable for this purpose. This requirement of Basic Computer knowledge Certificate is relaxable in case where a candidate has studied Computer as a subject in matriculation or Class XII or Higher educational qualification and in such case a separate Certificate will not be insisted upon.
- (iv) Candidate should have a valid license of two wheeler or light motor vehicle. Persons with Disability are exempted from the possession of license.
- (v) A candidate not having valid driving license at the time of appointment shall not earn periodical increment in pay till production of such license or for a period of five years from the date of appointment whichever is earlier and after production of such license or expiry of such five year period, pay shall be restored prospectively to the level pay would have reached had periodical increment in pay was not withheld and no arrears of pay shall be paid for the intervening period.

(C) Multi Tasking Staff (Administrative Office/Sub Ordinate Office):-

- 10th Standard pass from a recognized board.
- (ii) Knowledge of local language (i.e. Hindi). The candidate should have studied local language (i.e. Hindi) at least up to 10th standard.

10. Order of preference for Division/Unit allotment:-
