6. Selection Procedure:

- Those candidates who are already in Government service should produce NOC (No i) Objection Certificate) from the respective HoDs (Heads of Departments) at the time of the Computer/ Skill test.
- Canvassing directly or indirectly shall disqualify a candidate. ii)
- iii) No TA/DA will be admissible for attending the OMR based written test/ Skill test.
- iv) There will be no preference for place of posting. However, the Government may take into consideration nearest proximity of the permanent address, need of the department/ any other requirements in public interest.
- v) After the selection, allocation of Departments/ Posts shall be on the basis of their merit and post carrying higher Grade Pay. This shall be in conformity with all existing reservation rules.
