(2) The qualification prescribed by RCI, New Delhi under secondary and senior secondary level will also be considered for eligibility except graduation, which will be considered only as mentioned above.

- (iii). Written test will be conducted of MCQs through CENTA. The test will be of 100 marks of 2 hours durations consisting of two sections as stated above. The minimum score will be of 45 for SC/PH and 50 marks for other categories in aggregate out of 100 is required for eligibility. Those candidates, who will qualify the written test, will be called for document verification in the Parishad.
